**Any and all complaints filed with the FTC about Trump University and/or Trump Entrepreneurship Initiative from January 1, 2005 through December 31, 2010. We understand these exact documents were recently released to reporter Matt Novak of Gizmodo and reported here <http://gizmodo.com/these-former-students-say-trump-university-was-a-scam-1726235122> . We are requesting the same documents that were sent to Mr. Novak. We hope that because of this recently fulfilled release, this request may be expedited.**

I agree to pay reasonable duplication fees for the processing of this request in an amount not to exceed \$100. However, please notify me prior to incurring any expense in excess of that amount.

As a representative of the news media, I am only required to pay for the direct cost of duplication after the first 100 pages. Through this request, I am gathering information on what former students had to say about Trump University which was run by a man who is a candidate for President of the United States. This information is being sought on behalf of CBS News.

Please waive any applicable fees. Release of the information is in the public interest because it will contribute significantly to public understanding of this candidate's business practices.
