**Re: Low Flying Aircraft in NW Washington State**  
**Subject: Abuse of power**

Dear Secretary of the Air Force Office of Public Affairs  
Community Relations Division:

It was my hope that contacting the FAA would have been simply all I needed after composing emails in prior in regards to the above mentioned topic. It is with great seriousness, I respectfully ask that you look into the situation as it pertains to my plight each and every day around the Puget Sound area.

More specifically between Tacoma and Puyallup, WA next to I-5 and 512 freeways and North to Northeast of Base that seems often with most heading Northeast North or due North . One always is on the Northside of Puyallup typically lower level and another out of East near South Hills Spencer Air or old Thun Field and now owned I think by County.

Initially the craft seemed to all be props out of Puyallup and some helicopter folks back in late 2013 and into 2014. I have seen what I think was the Air National guard next to Pierce County Sheriffs in South Hill Puyallup pull a stunt twice that really was something out of the ordinary.<sup>1</sup> One Friday at the end of summer in 2013 at about exactly 5pm, a transport chopper flew from the East directly towards my home in very loud and low approach. I ran to garage to get camera phone and once they hit right above my basketball court, it stopped hard and banked left hard and upwards to with continuation towards to Air Guard yet looked like it went towards Fort Lewis from my perspective.<sup>2</sup> I faked like I took pictures as it was directly over my head so low, it was surreal. What was more perplexing was I was staining my fence and a few folks were outside as it was nice weather considering how later in the year it was.<sup>3</sup> Yet right before the approach, everyone went indoors as I will not forget myself thinking about the timing. I drew a picture that seemed to show larger older military green transport. To make things more shocking, the following Sunday after church while walking into the house, my wife and I heard this and I ran out to back and witnessed essentially the same thing as the prior Friday, yet not as low, not as aggressive but menacing nevertheless.

I have had one time late one night on the Sunrise Blvd. that a slow moving fixed wing I assumed was a helicopter fly so low and just over me I was able to take picture in the night, under foggy conditions and it's quite clear what is going on.<sup>4</sup> I have vids and countless pictures and logs with witnesses to events in question. They have participated with folks on the ground as my ability to have a normal life is not possible as its clear other officials are aware considering how close to Auburn traffic control we are and fixed craft flying South of base and other hard to see craft with one blinking light always darting North and South in tricky ways.<sup>5</sup> The craft out of the South and the one in North have too good of instinct and vision to be just average pilot and I think it's either authorities with civilian or Military and others. My other remembering of incident was when I picked my kid up at bus stop and two little bell like choppers were flying low in the East near me and acting as if it was some cat and mouse game of hide and seek. Another was when I helped on a roof one weekend and a few low flying choppers flew overhead.<sup>6</sup> I have many countless examples and proof yet manifest clearly would show anytime I leave home at night I face this.

My hope is not to have negative depiction and find honest person willing to stop madness of abuse of power and entrapments wrongly put on me. It is no secret the harassment I face and it seems to divert attention away from myself stumbling onto large criminal group.<sup>7</sup>

I am using another PC as others have been compromised by secret hidden apps that log my inputs on electronics, yet I will give some picture indications on this as well and if anyone ever wants to see better examples or explore better detailed question and answers I am willing at any time as I seek nothing and feel I have good indication of who has started yet that fell on deaf ears to what I forensic recovery of hard drives showed or what my ex-wife was involved with.<sup>8</sup>

My desire is to have someone investigate or stop it, as I assure you, one hundred percent I am telling the truth and will do my best to explain if necessary. I just wish it would stop as it's totally illegal and buzz overs of home that went on for a long time finally somewhat under control. It has violated many things in my life a lot more than folks may ever be willing to admit.<sup>9</sup>

Thank you for any attention you give to this matter as I will be thankful and hopeful it simply isn't twisted into another negative way towards me as I don't deserve anything that has transpired form many people.
