Dear Human Resources:

Having lived in Puyallup most of my life and having a large investment in the community I am saddened to think, when a Citizen asks or needs help with crimes, he actually faces more of the same. I have tried repeatedly to figure a way to mitigate the abuse of power without offending, stopping blatant merchant discrimination and authorities participating in creation of negative depictions and stereotype simply from my impending and now marital status.

I have faced more crimes, more harassment more abuse than any person should ever have to go thru. Considering my record is clean without even a traffic ticket, growing up and participating in the growth of our City and South Hill over the years. I feel quite unfortunate to be the poster boy of false slanderous ideals by some religious sect trying to portray quality member of the community, when in fact, they are nothing more than criminals.

I have been subjected to absolute discrimination and abuse that finds authority figures organizing my neighbors to find a way to exercise mental control, intimidation and bias and grow to the point my family, kids, neighborhood and self employed business is destroyed. Its one thing to find no due process in the courts, anti-trust, treason and slander that ultimately with the State and City help, destroyed my business with the full knowledge of end results and how they would occur. I have faced bribery, ID theft and frauds in every imaginable way. I witness sealed documents categorically false like the sudden onrush of abuse and false statements local authorities put on me wrongly. I faced overzealous fake assaults on my home, drive by shootings, property damage, countless auto damage, banks that take all my money or insurance companies wrongly drop me simply from my marital status. I have younger authorities who attend the community drinking parties and one who I wrongly paid to intoxicate my wife on Christmas eve think its funny to chase me down with loud siren. I have been wrongly made to sit on curbs for hours while illegal search and seizure takes my legal papers to upset my litigation and miss appointments. I find seven police officers surround my home and while reading the bible after a workout in my garage I am suddenly surrounded by Sheriff deputies asking, "where my guns are". Despite never owning a gun of any kind, I have these guys show up with Dogs while my kids are at home, and they start rummaging thru my garage and then open all the bay doors as neighbors start parading in

front of my home as if I am some spectacle , while the officers laugh and giggle about with questions, "do I know what this is about". No matter what the answer considering how many times this type of thing occurs, they wrongly say, "paranoid" and later I find its only for the courts with separation that this community sits and watch me lose every single thing in my life and no contact with my kids in two years? This was after wife broke laws and orders taking kids out of State and the Country.

Just after I refused a bribe and discovered my partner took me for well past a million, I learn my wife did much more and the local banks without court order illegally have allowed my wife all my accounts and gave her a job is the most ridiculous abuse and illegal action anyone can think of. I try every way I know of to get any help as systematically the ID Theft and Frauds of ex partner and wife going to others as some battered woman, kicked up a firestorm of hate and suddenly I face angry mobs of YWCA to YMCA or even neighbors to off duty folks following and staging accidents, road blocks, assaults with cars, hi beam lights in my eyes that continue two years later. I am never getting help from authorities as experience and taped recordings of me getting assaulted in front of twenty cars has the buddy of my brother who is local product continue his game of fake arrest, making false comments and trying to play two cops against me, this after he parks when its dark with lights on facing my house for just under an hour.

I am detained and made to stand in middle of the road in Safeway parking lot after being subjected to bumps, pushes, loud heckles and told I was treas
