The <u>National Training Program (NTP)</u> is the official source for consistent, accurate, and reliable information about the Centers for Medicare & Medicaid Services (CMS) administered programs—Medicare, Medicaid, the Children's Health Insurance Program (CHIP), and the Health Insurance Marketplace.

This job aid features key websites, associated resources, and tools to help our partners, stakeholders, not-for-profit professionals, and volunteers (who work with consumers and their families) help others make informed decisions about their health care coverage.

Access the <u>CMS National Training Program (NTP) Learning Management System</u> (LMS) which enables end-users to take courses, download documents, watch videos, and use other helpful tools. Sign up for the listserv by selecting "<u>Get email updates</u>" at the top center of the site to get monthly updates and information on upcoming training events and educational materials.

- <u>CMS.gov</u> is the official website for the Centers for Medicare & Medicaid Services (CMS). The content is used primarily by partners, providers, and researchers. Use the website to:
 - Research issues using CMS manuals
 - Use guidance to find details about what Medicare covers
 - Search the <u>Data Navigator</u> to locate specific types of information (e.g., data files, publications, statistical reports, etc.)
 - Learn about the <u>Innovation Center</u> which supports the development and testing of innovative health care payment and service delivery models.
 - Get free educational materials for health care professionals on CMS programs, policies, and initiatives through the <u>Medicare Learning Network® (MLN)</u>.

- Medicare.gov Official website for Medicare information. It's primarily for people with Medicare and their caregivers. Use the website to:

 - Find <u>doctors</u>, <u>hospitals</u> and <u>suppliers</u>
 - Read, print, or order free Medicare publications
- Medicaid.gov CMS website that's the primary resource for states. It has information about eligibility, enrollment, and funding. Use the website to:
 - Access the <u>State Resource Center</u>

- InsureKidsNow.gov CMS website that helps families find free or low-cost health and dental coverage for kids and teens through the Children's Health Insurance Program (CHIP). Use the website to:

- HealthCare.gov Official website for the federal Health Insurance Marketplace. Helps consumers find the health insurance best suited for their needs—private and public programs. Use the website to:
 - Apply for and enroll in health insurance plans, Medicaid or CHIP
 - <u>Re-enroll, change, or cancel</u> plan options
 - <u>Get answers</u> to Marketplace questions
- Marketplace.cms.gov Official Health Insurance Marketplace information source for assisters and outreach partners to get information about assister programs and tools to help existing and new Marketplace consumers. Use the website to get:
 - Applications, forms and notices
 - <u>Technical assistance resources</u>
 - Outreach and educational materials
- <u>Socialsecurity.gov</u> Official website of the U.S. Social Security Administration (SSA). Use the website to:
 - Apply for benefits, like <u>retirement</u>, <u>Medicare</u>, <u>Extra Help</u>, and <u>disability</u>
 - Update your mailing address through <u>MySocialSecurity</u>
 - Research issues using SSA's <u>online manuals</u>
- Regulations.gov Source for U.S. government regulations from nearly 300 Federal agencies, including CMS. This site includes Final Rules and Regulatory Agendas that list regulations each agency plans to issue. You can use the website to review and <u>submit</u> <u>comments</u> on Proposed Rules.
- <u>eCFR.gov</u> (Electronic Code of Federal Regulations (e-CFR)) This is where you'll find the most up-to-date Medicare regulation information (Medicare (Public Health) is Title 42). You can use the website to find regulations of implemented Final Rules.
