Would you please be able to confirm what entity information should be listed in the acquired entities boxes in 3a?

We have one UPE and ten wholly-owned acquired entities. Based on this statement in the instructions, ""It is not necessary to list every subsidiary wholly-owned owned by an acquired entity," I normally list only the top level entities. However, in this case, we have one UPE with ten wholly-owned entities whose assets are being sold. They are not stacked so that each is a top level entity within the UPE. Do I need to list them all separately in the entity boxes when they are described is the Transaction Description? Thank you.
