**JOINT REPORT REGARDING AMENDED PRE-HEARING SCHEDULE**


Complaint Counsel and Respondents GTCR LLC; GTCR BC Holdings, LLC; and Surmodics, Inc., (collectively, “the Parties”) hereby submit this joint report pursuant to the Court’s June 23 Order, which directed the Parties to advise the Court whether the proposed schedule included in the June 23 Order is acceptable. The Court’s proposed schedule is currently acceptable to the Parties.

Given the pending Federal Action, *FTC v. GTCR BC Holdings, LLC*, Case No. 1:25-cv-02391 (N.D. Ill.), the Parties anticipate they may need to seek revisions to the schedule at a later time. Therefore, the Parties respectfully suggest that the Court set a joint status report to be filed within ten business days of the conclusion of the preliminary injunction hearing to address whether the Parties believe any further modifications of the schedule may be required.
