I write to inform you of the following: On August 1, 2022, through an internal FTC repository accessible to all FTC employees, Sophia Calderón accessed a Commission document that we believe should have been screened from Complaint Counsel. The portion of the document she saw appeared to memorialize a meeting between Commissioners regarding Complaint Counsel's Motion for Summary Decision in the above-captioned case.
