## The National Do Not Call Registry

The National Do Not Call Registry provides an easy and efficient way for consumers to tell companies they don't want to receive most telemarketing sales calls. Robocalls that are sales calls are illegal whether a number is on the Registry or not, unless the caller has written permission from a consumer.

Since its inception in 2003, the Registry has continued to grow. As of September 30, 2025, there were 259 million active registrations. Consumers can register multiple phone numbers on the Registry by registering online at [donotcall.gov](https://donotcall.gov) or calling a toll-free number (888-382-1222) from the telephone numbers they wish to register. Telemarketers and sellers must remove numbers added to the Registry from their call lists at least every 31 days. Organizations can access the Registry at [telemarketing.donotcall.gov](https://telemarketing.donotcall.gov).

Companies that make unwanted calls to consumers may be violating the Do Not Call rules. Consumers can report the call to the Federal Trade Commission (FTC) online at [donotcall.gov](https://donotcall.gov) or by calling the toll free number. Law enforcement officials review these complaints, as well as consumer registration and telemarketer access information, through the Consumer Sentinel Network, a secure online database maintained by the FTC. ## The Data Book

The *National Do Not Call Registry Data Book* contains statistical data about phone numbers on the Registry, telemarketers and sellers accessing phone numbers on the Registry, and complaints consumers submit to the FTC about telemarketers allegedly violating the Do Not Call rules. The FTC monitors the data for accuracy and occasionally makes modifications to address potential problems. Statistical data on complaints is based on unverified complaints reported by consumers, not on a consumer survey.


### Inside the numbers

- When we report the total number of DNC complaints, we break it down to show how many were robocalls and how many came from live callers. With a few exceptions, telemarketing robocalls are illegal, whether or not a number is on the Do Not Call Registry. As always, when it's a live caller, we verify that the consumer's telephone number was registered on the DNC registry before we take the complaint.
- Our online complaint form asks for the topic of the call.
  - Consumers can choose to report specific topics, such as reducing debt, vacation & timeshares, and several other categories. Not everyone who files a complaint reports a topic.
  - The Data Book does not include statistics where a consumer chose "Other," or topics less likely to violate the Do Not Call rules, such as debt collection, political, or charitable calls.
- The Data Book includes a state-by-state analysis of DNC complaints. This is how we identify a consumer's state:
  - If consumers report their state, we use the state they report.
  - If consumers do not report their state, we use their area code.
  - The state-by-state analysis also includes the top 10 topics consumers reported.
- The underlying data in the report is available on our open government site where we post our daily complaint data at: [www.ftc.gov/data](http://www.ftc.gov/data).
- States are ranked based on the number of registrations or complaints per 100,000 population. Complaint figures include the total number of FY 2025 complaints submitted to the FTC. Population estimates are based on 2023 U.S. Census population estimates (2019-2023 American Community Survey 5-Year Estimates).
- For the purposes of this report, "active registrations" are those registrations consumers have placed on the Registry that have not been subsequently deleted by the consumer or removed by the FTC. The FTC removes numbers that have been disconnected and reassigned. Numbers that have been disconnected but not reassigned remain on the registry.



Telemarketers and sellers can access up to five area codes on the Registry for free. To access more than five area codes, they must pay a fee. Organizations that are not selling goods or services are "exempt" and can access numbers on the Registry for free. This includes organizations asking for charitable contributions, raising money for political purposes, or conducting surveys. It also includes organizations calling **only** people they have an established business relationship with or who have given the organization written permission to call.

## Complaints by Call Type and Fiscal Year





## FY 2025 Complaints by Topic\*




