**JOINT MOTION TO ENTER  
STIPULATED ORDER FOR  
PERMANENT INJUNCTION  
AND OTHER RELIEF**

Plaintiff Federal Trade Commission (“FTC” or “Commission”), and Defendants, Match Group Americas, LLC and Humor Rainbow, Inc. (collectively “Defendants”), respectfully submit the attached proposed Stipulated Order for Permanent Injunction and Other Relief (“Stipulated Final Judgment”) to fully resolve this matter.

The Complaint alleges that Defendants violated Section 5 of the Federal Trade Commission Act, 15 U.S.C. § 45, concerning the provision of OkCupid user data to a third-party company contrary to promises that Humor Rainbow, Inc. made to users in OkCupid’s privacy policies. *See* Doc. No. 1. Humor Rainbow, Inc. owns and operates the OkCupid dating platform. Defendants neither admit nor deny any of the allegations in the Complaint, except as specifically stated in the Stipulated Final Judgment, and that only for purposes of this action, they admit the facts necessary to establish jurisdiction.

The Stipulated Final Judgment would enjoin the alleged practices. The Stipulated Final Judgment was signed by Defendants and Plaintiff's counsel. Plaintiff and Defendants respectfully request that this Court enter the Stipulated Final Judgment.


