## WARNING LETTER

Re: Unsubstantiated claims for Coronavirus treatment or prevention

To Dr. Sieman:

This is to advise you that FTC staff has reviewed your website at <u>https://newleafcenters.com</u> on April 22, 2020. We also reviewed your social media websites at <u>https://www.instagram.com/newleafcenters, https://www.twitter.com/newleafcenters</u>, and <u>https://www.facebook.com/newleafwellnesscenters/</u>, where you advertise services such as IV therapy, peptide therapy, and hormone therapy, and direct consumers to your website <u>https://newleafcenters.com</u> and to a phone number to call your office. We have determined that you are unlawfully advertising that certain products treat or prevent Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus treatment or prevention claims on your websites include:

• "Thymosin Alpha-1 (Ta-1). Ta1 may have clinical benefits in disorders where immune responses are impaired or ineffective, such as ... [a]ny viral disease .... Thymosin modulates the immune system! This should be used as a treatment adjuvant and a prophylactic ad [sic] can help with may [sic] conditions beyond viral illness! Most will dose it at 450mcg daily. Call to schedule 888-728-7555! #stayhealthy #coronavirus #covid19 #coronavirusinformation ... #keepprotected" [from your March 15, 2020 post on https://www.instagram.com/newleafcenters]

- "IMMUNE BOOST. 30ml Vitamin C IV w/ Glutathione Push. \$100.... Beat Covid 19 with Glutathione ... Protect yourself. Glutathione acts as an important antioxidant in your body. That means it helps combat free radicals. These are molecules that can damage your body's cells.... #coronavirus #covid19 #coronavirusinformation ... #keepprotected ...." - "Dr. Sieman [the medical director of New Leaf Wellness] has achieved the 'Record of Achievement' from World Health Organization for COVID-19 and 'Certificate of Completion on The Coronavirus Disease Pandemic' from NetCE who supports the improvement of patient care, NetCE is jointly accredited by the Accreditation Council for Continuing Medical Education (ACCME), the Accreditation Council for Pharmacy Education (ACPE), and the American Nurses Credentialing Center (ANCC), Pictured is Dr Sieman with the Certificate of Completion on The Coronavirus Disease Pandemic for both IA and OK. #cronavirus [sic] #cronabirus19 [sic] #COVID19 #cronavirusnews [sic] #Pandemic! #slowthespread #slowthespreadofcovid19." [*Angela, New Leaf Wellness*]: We continue to say thank you to our existing patients that are continuing on their hormone therapy, you guys are ahead of the game. We welcome all new patients; we're here for you in this crisis of COVID-19. Again, we do the vitamin C injections, we do the high-dose vitamin C IVs, you can get vitamin D3 here in our clinic . . . ." • "[*Angela, New Leaf Wellness*]: Today we're going to focus on vitamin C IVs and why they're so important . . . we're joined by our nurse practitioner, Jenny, and

[*Jenny*]: Absolutely. So, Vitamin C, so, so important. We're actually hearing on the news now that patients who are diagnosed or suspected of having COVID-19 are being treated with high-dose Vitamin C IVs. Our IVs are a simple procedure that we

It is unlawful under the FTC Act, 15 U.S.C. § 41 *et seq.*, to advertise that a product can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, including, when appropriate, well-controlled human clinical studies, substantiating that the claims are true at the time they are made. For COVID-19, no such study is currently known to exist for the products or services identified above. Thus, any coronavirus-related prevention or treatment claims regarding such products or services are

not supported by competent and reliable scientific evidence. You must immediately cease making all such claims.

You are also advised to review all other claims for your products and immediately cease making claims that are not supported by competent and reliable scientific evidence.
