**WARNING LETTER**

Re: Unsubstantiated Claims for Coronavirus Prevention or Treatment

To Whom It May Concern:

This is to advise you that on September 14, 2020, FTC staff reviewed your social media websites at [www.facebook.com/GotaysGroupSystem/](http://www.facebook.com/GotaysGroupSystem/) and [www.facebook.com/Cebilon-Puerto-Rico-573251169732687/](http://www.facebook.com/Cebilon-Puerto-Rico-573251169732687/), where you direct consumers to contact you via telephone to purchase the aura Cebilon water filtration system. We have determined that you are unlawfully advertising that certain products prevent or treat Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus prevention or treatment claims<sup>1</sup> made on your social media websites include the following:

- In a Facebook post, posted to [www.facebook.com/GotaysGroupSystem/](http://www.facebook.com/GotaysGroupSystem/) on March 26, 2020, you share an image that includes a depiction of an aura Cebilon water purifier and state: "Gotay's group system viene atacando duro al coronavirus!!! Con la gran oferta el 2x1. No dejes que el coronavirus te quite tu felicidad y la de tu familia tambien[.] Mantengase sano usted y su familia. Haci que purifica tu agua y purifica tu aire con GOTAY'S GROUP SYSTEM matamos el virus!!! 787-385-3418."<sup>2</sup>
- In a Facebook post, posted to [www.facebook.com/GotaysGroupSystem/](http://www.facebook.com/GotaysGroupSystem/) on March 31, 2020, you state: "No dejes q el Corona Virus Afecte tu hogar tomando Agua alkalina proteges los tuyo,"<sup>3</sup> and share an image that includes a telephone number and a depiction of an aura Cebilon water purifier.

- In a Facebook post, posted to [www.facebook.com/Cebilon-Puerto-Rico-573251169732687/](https://www.facebook.com/Cebilon-Puerto-Rico-573251169732687/) on March 31, 2020, you state: "Vamos a matar el Corana [sic] Virus juntos con GOTAY GROUP SYSTEM=CEBILON AURA P.R.,"<sup>4</sup> and share an image that includes a telephone number and a depiction of an aura Cebilon water purifier.

It is unlawful under the FTC Act, 15 U.S.C. § 41 *et seq.*, to advertise that a product can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, substantiating that the claims are true at the time they are made. For COVID-19, no such study is currently known to exist for the product identified above. Thus, any coronavirus-related prevention or treatment claims regarding such product are not supported by competent and reliable scientific evidence. You should immediately cease making all such claims.

You are also advised to review all other claims for your products and immediately cease making claims that are not supported by competent and reliable scientific evidence.
